I

The name of this corporation is California GREAT OUTDOORS.

II

A. This corporation is a nonprofit mutual benefit corporation organized under the Nonprofit Mutual Benefit Corporation Law. The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under such law.

B. The specific purpose of this corporation is to function as a social and recreational gay and lesbian outdoors club offering low-cost outings in California's and surrounding states' finest wilderness areas. Membership and participation in the activities of this corporation are not subject to discrimination on the basis of race, ethnic heritage, color, religion or creed, age, socio-economic status, sex, and sexual orientation. The characteristics of the corporation are such as to provide for personal contact, comingling and fellowship with a common objective directed toward pleasure, recreation and such kindred purposes of a nonprofit nature.

Notwithstanding any of the above statements of purposes and powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the specific purposes of this corporation.
